RESOLUTION OF THE DELAWARE COUNTY, INDIANA BOARD OF COMMISSIONERS TO TRANSFER COUNTY-OWNED PROPERTY TO THE WES DEL COMMUNITY SCHOOLS

WHEREAS, the Delaware County Board of Commissioners, as the legislative body and executive of Delaware County, Indiana (hereinafter, the "Commissioners"), owns certain personal property that is described as a 2018 Chevrolet Silverado pick up truck with a VIN ending in 19881 that was used by the Delaware County Sheriff in its operations (hereinafter, the "County Property");

WHEREAS Wes Del Community Schools has expressed an interest in receiving and using said vehicle as part of its daily operations;

WHEREAS Wes Del Community Schools District desires to acquire the County Property from the Commissioners to be used in their daily operations; and

WHEREAS the Commissioners desire to transfer said County Property to Wes Del Community Schools, subject to acceptance of said County Property by the school district and upon the terms and conditions stated herein.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY, INDIANA THAT:

1. The Delaware County Board of Commissioners shall transfer said County Property, as described above to Wes Del Community Schools upon acceptance of the County Property by Wes Del Community Schools.
2. The school district's acceptance of the County Property shall be demonstrated by transfer of the title from the County to the School District corporation.
3. This Resolution shall be effective upon adoption.
