**JURY CONVICTS TARRON CONWELL OF
ATTEMPTED MURDER OF LAW ENFORCEMENT OFFICERS**

Muncie Indiana – Today a Delaware County jury deliberated for approximately 4 hours before convicting Tarron H. Conwell (DOB 12/29/2003) of:

- Count 1: Attempted Murder, a Level 1 Felony
- Count 2: Criminal Recklessness, a Level 5 Felony as a lesser included offense of Attempted Murder, a Level 1 Felony
- Count 3: Attempted Murder, a Level 1 Felony
- Count 4: Unlawful Carrying of a Handgun, a Level 5 Felony
- Count 5: Resisting Law Enforcement, a Level 6 Felony

A copy of the Affidavit of Probable Cause that was originally filed with the case is attached. The Honorable Judi L. Calhoun, Judge of the Delaware Circuit Court No. 1 set sentencing for July 24, 2024. Pursuant to Indiana law:

- Each Level 1 Felony is punishable by 20 – 40 years in prison and up to a \$10,000 fine.
- A Level 5 Felony is punishable by 1 – 6 years in prison and up to a \$10,000 fine.
- A Level 6 Felony is punishable by 6 months – 2.5 years in prison and up to a \$10,000 fine.

After the verdicts were returned, Delaware County Prosecuting Attorney Eric Hoffman said “Police officers form the thin blue line that stands between criminals and their would-be victims. In doing so, they routinely put their life in jeopardy so that we may live in a civilized and safe society. Officers have the absolute right to defend their own lives so that they may go home at the end of their shift. If you choose to fire a gun at a police officer, you do so at your own peril. As Prosecutor, I will not tolerate acts of violence against law enforcement. I am proud of Deputy Prosecutors Steve Sneed and Maricel Driscoll, ISP Detective Ron Halbert and Prosecutor’s Investigator Kira Curtis for their hard work and dedication in this case.”

The basis and reasons why this officer believes that said arrestee committed the aforesaid offense(s) in Delaware County, State of Indiana, are as follows:

On 6-23-2023, the Delaware County Sheriff's Department was searching for this suspect for an alleged prior crime. The Sheriff's Department Investigators located this suspect outside his residence located at 3608 S. Mock Avenue, Muncie, Indiana. When Deputies went to arrest this suspect, the suspect fled on foot from Deputies, ignoring verbal commands, and while fleeing, drew a concealed handgun and began to fire several rounds at pursuing Deputies. One pursuing Deputy's marked police vehicle was struck by the suspect's gunfire and other Deputies on foot were shot at also. A subsequent search of the suspect's residence, via search warrant, revealed the presence of suspected marijuana and other firearms.

I affirm under penalty of perjury that the foregoing is true and accurate to the best of my information and belief.
