**PROSECUTOR CONCLUDES REVIEW  
OF JANUARY 2024 FATAL POLICE PURSUIT**

*Muncie Indiana* – Prosecuting Attorney Eric M. Hoffman has concluded his review of the January 24, 2024 police pursuit that resulted in death and loss of a fetus. At the outset, Prosecutor Hoffman would like to thank the Indiana State Police for conducting a complete and thorough investigation. Below is a brief timeline of events that led up to the police pursuit and crash (the rules of professional conduct only permit prosecutors to comment on facts that are already available in the public record):

September 28, 2022      Oliva LaRue was arrested for Dealing in Cocaine, a Level 2 Felony, Dealing in Cocaine, a Level 3 Felony, Possession of a controlled substance, a Class A Misdemeanor, and Failure to appear.

October 4, 2022      The Delaware County Prosecutor's Office filed formal charges against Olivia LaRue in Cause No. 18C02-2210-F2-32 for the above crimes.

It is important to remember that any accusation that someone has committed a crime, an arrest and/or the filing of a criminal charge is simply an allegation and is not evidence of guilt. All suspects are presumed innocent unless and until proven guilty beyond a reasonable doubt at trial.

October 4, 2022      After posting bail, Olivia LaRue was released from jail.

August 15, 2023      Madison County law enforcement arrested Olivia LaRue for alleged new criminal activity.

August 18, 2023      The Madison County Prosecutor's Office charged Olivia LaRue with Dealing in Cocaine, a Level 2

Felony, Dealing in a Narcotic Drug, a Level 2 Felony, and Identity Deception, a Level 6 Felony. Again, it is important to remember that any accusation that someone has committed a crime, an arrest and/or the filing of a criminal charge is simply an allegation and is not evidence of guilt. All suspects are presumed innocent unless and until proven guilty beyond a reasonable doubt at trial.

- August 18, 2023      The Delaware County Prosecutor filed a motion to revoke Olivia LaRue's bail in Cause No. 18C02-2210-F2-32 based on the Madison County arrest and subsequent criminal charges. In the Motion, the Prosecutor specifically alleged, "the Defendant poses a risk to the physical safety of another person or the community." Delaware Circuit Court No. 2 Judge Kimberly Dowling set a hearing on the Motion to revoke for October 12, 2023.
- October 12, 2023      Olivia LaRue failed to appear for the hearing on the Prosecutor's Motion to Revoke bail. The Court issued a bench warrant for her arrest.
- January 24, 2024      Law enforcement attempted to serve outstanding arrest warrant on Olivia LaRue. LaRue fled from police, which resulted in a crash.

On today's date, the Prosecuting Attorney Eric M. Hoffman formally charged Olivia L. Larue (DOB 03/28/1984) with the following criminal offenses:

- Count 1: Resisting Law Enforcement Resulting in Death, a Level 3 Felony.
- Count 2: Operating a Motor Vehicle While Intoxicated Resulting in Death, a Level 4 Felony.
- Count 3: Driving While Suspended Resulting in Death, a Level 5 Felony. Level 5 Felony.
- Count 4: Operating a Motor Vehicle Causing Serious Bodily Injury, a Level 5 Felony.
- Count 5: Resisting Law Enforcement Resulting in Seriously Bodily Injury, a Level 5 Felony.

- Count 6: Driving While Suspended, Resulting in Serious Bodily Injury, a Level 6 Felony.
- Count 7: Involuntary Manslaughter, a Level 5 Felony.
- Count 8: Resisting Law Enforcement, a Level 6 Felony.
- Count 9: Unlawful carrying of a Handgun, a Level 5 Felony.
- Count 10: Possession of a Controlled Substance, a Level 6 Felony.
- Count 11: Criminal Recklessness, a Level 5 Felony.
- Count 12: Aggressive Driving, a Class A Misdemeanor.
- Count 13: Failure to Obey Traffic Control Device, a Class A Infraction.
- Count 14: Reckless Driving, a Class A Misdemeanor.

It is important to remember that any accusation that someone has committed a crime, an arrest and/or the filing of a criminal charge is simply an allegation and is not evidence of guilt. All suspects are presumed innocent unless and until proven guilty beyond a reasonable doubt at trial.

The charges are pending in the Delaware Circuit Court No. 3. The Honorable Judge Douglas K. Mawhorr will set the case for an initial hearing. Copies of the Charging Information and Affidavit of Probable Cause for Arrest Without a Warrant that were filed with the Court are attached.

Pursuant to Indiana law:

- A Level 3 Felony is punishable by 3 – 16 years in prison and up to a \$10,000 fine.
- A Level 4 Felony is punishable by 2 – 12 years in prison and up to a \$10,000 fine.
- A Level 5 Felony is punishable by 1 – 6 years in prison and up to a \$10,000 fine.
- A Level 6 Felony is punishable by 6 months – 2.5 years in prison and up to a \$10,000 fine.
- A Class A Misdemeanor is punishable by up to 1 year in jail and a \$5,000 fine.

The Prosecutor's review also included a review of the actions of the law enforcement officers who engaged in the pursuit. After a review of the facts and

the applicable law, Prosecutor Eric M. Hoffman determined that the law enforcement officers involved did not commit any criminal acts. Therefore, those officers will not be charged with any criminal offenses.

Prosecutor Hoffman said “cases like these create frustrations on many fronts. First, in cases like this, a defendant has a pending felony case, is released on bail, and then allegedly committed a new felony offense. The Prosecutor’s Office took immediate action and filed a motion to revoke bail and have the defendant incarcerated pending trial. The August 18 Motion to Revoke bail specifically alleged “the Defendant poses a risk to the physical safety of another person or the community.” Nevertheless, the Delaware Circuit Court No. 2 set the motion for hearing on a date two (2) months after the motion was filed. The Defendant ultimately failed to appear for the hearing. It would seem that a motion to revoke bail in a felony case based on alleged new felonious activity would take precedence and require a prompt hearing. Secondly, when a police officer turns on the lights and sirens – pull over and stop, it is as simple as that. If you do not, you can fully expect that the police will pursue you and take you into custody. Appellate courts, in both the federal and the state system they have said that police officers ‘may and ought to pursue fleeing suspects’ and as the prosecutor and as citizen of this county I think as a society we should expect nothing less.”

The ethical rules for prosecutors in Indiana prohibit further comment on this matter. At this time, there will be no further comment.

Comes now, Anthony J. Klettheimer, who hereby affirms under the pains and penalties for perjury, deposes and says:

1. I am a law enforcement officer with the Indiana State Police Department and have been employed since December 15, 1996.
2. I am submitting this affidavit in support of criminal charges against Olivia L. Larue, d.o.b: 03/28/1984, a white, female, 5'04, 140, brown hair, and green eyes with an address of 222 West Centennial Avenue Apt #E3, Muncie, Indiana 47303, for the following criminal charges.

Count #1, Level 3 Felony, I.C. 35-44.1-3-1, Resisting Law Enforcement Resulting in Death.

Count #2, Level 4 Felony, I.C. 9-30-5-5, OWI causing death.

Count #3, Level 5 Felony, I.C. 9-24-19-3, DWS resulting in death.

Count #4, Level 5 Felony, I.C. 9-30-5-4, OWI causing Seriously Bodily Injury.

Count #5, Level 5 Felony, I.C. 35-44.1-3-1, Resisting Law Enforcement Resulting in Seriously Bodily Injury.

Count #6, Level 6 Felony, I.C. 9-24-19-3, DWS Resulting in Seriously Bodily Injury.

Count #7, Level 5 Felony, I.C. 35-42-1-4, Involuntary Manslaughter.

Count #8, Level 6 Felony, I.C. 35-44.1-3-1, Resisting Law Enforcement with the use of a vehicle.

Count #9, Level 5 Felony, I.C. 35-47-2-1, Unlawful carrying of a Handgun.

Count #10, Level 6 Felony, I.C. 35-48-4-6, Possession of Cocaine.

3. The factual information supplied in this affidavit are based on my personal observations; my training and experience; my investigation of this matter; and information. Because this affidavit is being submitted for the limited purpose of providing probable cause for arrest without warrant, I have not included each and every fact known to me concerning this investigation. I have set forth only the facts that I believe are necessary to establish probable cause to believe that evidence, fruits, and instrumentalities of the violations of Indiana Code I.C. 35-44.1-3-1, 9-30-5-5, 9-24-19-3, 9-30-5-4, 35-44.1-3-1, 9-24-19-3, 35-42-1-4, 35-44.1-3-1, 35-47-2-1, and 35-48-4-6.
4. On or about January 23, 2024, I was requested by Indiana State Police Sgt. Scott Jarvis to respond to the Muncie Police Department (MPD) regarding a police pursuit that resulted in death and injuries. Once I arrived, I was requested by MPD Chief Nathan Sloan to take the lead of this investigation because the Muncie Police Department and the Delaware County Sheriff's Department were involved in the pursuit.
5. During my initial investigation, Delaware County Sheriff's Deputy Clinton Harper received information about Olivia L. Larue who was a fugitive, had a firearm in the vehicle, may take action with the weapon, and shoot at officers. Deputy Harper was able to locate Olivia L. Larue around 15<sup>th</sup> Street and Port Avenue (City of Muncie) get into the driver's side of a vehicle (Silver SUV), and a black male get into the passenger seat. Deputy Harper attempted to conduct a traffic stop around 12<sup>th</sup> Street and Gharkey Street (City of Muncie), but the vehicle took off. The vehicle refused to

stop and submit to the authority of law enforcement. Deputy Harper stated he continued to follow the vehicle, but lost sight of the vehicle at 18<sup>th</sup> Street and Macedonia Avenue (City of Muncie).

6. Olivia L. Larue had active arrest warrants for Possession of a Narcotic Drug Level 6 Felony, Driving while Suspended Class A Misdemeanor, Possession of Paraphernalia Class C Misdemeanor, in Cause No. 18C02-2207-F6-393 and well as Dealing in a Narcotic Drug Level 2 Felony, and Identity Deception Level 6 felony in Cause No. 48C03-2308-F2-2431.
7. The Muncie Police Department continued the pursuit with the Ford SUV vehicle. The vehicle refused to stop and submit to the authority of law enforcement. During the pursuit, the Ford SUV crashed into an Acura at the intersection Mulberry Street and Main Street (City of Muncie).
8. Indiana State Police M/Trp. Jeremy Perez was also informed that during the pursuit, the Ford SUV had fled from the Muncie Police Department that they were actively pursuing the vehicle at the time of the crash. M/Trp. Perez was advised that the Ford had been traveling west on Main Street and ran the red light at Mulberry Street, striking the Acura.
9. The Acura was driven by Acacia A. Hammond and passenger Javonta T. Jones. The driver, Acacia A. Hammond, sustained critical injuries and the passenger, Javonta T. Jones, suffered fatal injuries.
10. M/Trp. Jeremy Perez, Indiana State Police Sgt. Danielle Elwood, and Indiana State Police Trp. Blake Stephenson went to Ball Memorial Hospital and spoke with the driver of the Acura (Acacia A. Hammond). Hammond stated she and her brother (Javonta T. Jones) were driving north on Mulberry Street. Hammond stated that their light was green. Hammond stated as she crossed the intersection, she heard a loud boom, and the next thing she knew, she was hanging upside down and her brother was hanging in front of her.
11. According to medical records obtained from Ball Memorial Hospital, Hammond sustained injuries including the following: acute, traumatic rupture of the uterus with intraperitoneal fetus; active bleeding extending from the uterine cavity in the lower quadrant; grade 5 liver injury, and grade 5 splenic injury. Hammond was 16 weeks

pregnant at the time of the crash and Hammond lost the fetus as a result of the vehicular crash.

12. An autopsy was performed on Javonta T. Jones that revealed his cause of death was multiple blunt force injuries.
13. Olivia L. Larue Toxicology Report-Drug Analysis showed confirmation results for Fentanyl, Norfentanyl, and positive findings for Benzoylcegonine, and cocaine.
14. A search warrant was obtained for the Ford SUV vehicle driven by Olivia L. Larue. Indiana State Police F/Sgt. John Petro collected the following items from the vehicle: a clear plastic bag with a white colored substance, another clear plastic bag, a brown colored glass pipe, a piece of clear plastic, black and green colored digital scale containing residue, clear glass pipe, a green colored bag, and inside the bag was a clear plastic bag containing a white colored substance. The Substance was submitted to NMS Labs for chemical analysis. NMS Labs Drug Chemistry Final Report showed Item #5608-08 a clear plastic bag with a white colored substance showed confirmed for Cocaine with a weight of .057g (+/-0.02) (net). A Coach brand purse was located under the front driver seat. The purse contained a wallet that contained cards with the names Olivia Larue, Mary L. Williams, and Emma Jane M Thornbury. Also, inside the purse were a purple, black, and green colored knife, metal knuckles, and a loaded DB, model DB9, 9mm handgun with serial number YJ8020.
15. Indiana Bureau of Motor Vehicles indicated that on the day of police pursuit and subsequent crash, Olivia L. Larue's driver's license status is suspended.
16. According to Olivia L. Larue's criminal history inquiry showed Larue was convicted of aggravated possession of drugs (Schedule I or II) Level 5 felony in County Common Pleas Court Dayton, State of Ohio with a final disposition on January 17, 2018, under charge tracking number #XR-6461582.

I hereby affirm under the pains and penalty of perjury, that the foregoing information is true, to the best of my knowledge and belief.
