RESOLUTION 24-40

WHEREAS, the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized Area; and

WHEREAS, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

WHEREAS, the FY 2022-2025 DMTIP needed to be amended to add INDOT project DES #2400605, Other Type Project (Miscellaneous) Electric vehicle charging infrastructure at 14000 W SR 28, Gaston, IN 47342; and

WHEREAS, the proposed amendment to the FY 2022-2025 DMTIP to add INDOT DES #2400605 was submitted to the Interagency Conformity Group (ICG) for confirmation of exempt status with the consultation period ending on August 27th, 2024; and

WHEREAS, the above proposed amendment to the FY 2022-2025 DMTIP was reviewed and approved by the TPC by email vote concluding August 27th, 2024.

NOW, THEREFORE, BE IT RESOLVED by the Transportation Policy Committee of the DMMPC as follows:

Section 1. That the FY 2022-2025 DMTIP is amended to add INDOT project DES #2400605 as shown in Exhibit A.
