RESOLUTION OF ADOPTION FOR APPROVAL FOR THE  
OFFICIAL DIGITIZED ZONE MAPS FOR DELAWARE COUNTY, INDIANA  
AND THE 2006-2007 ZONE MAP CHANGES

WHEREAS, the Delaware County Comprehensive Zoning Ordinance states that the Official Zone Maps for Delaware County, Indiana, be revised and updated to include the zone map changes on an annual basis; and

WHEREAS, work has been completed on the digital conversion of the Official Zone Maps for Delaware County, Indiana; and

WHEREAS, the zone map changes through 2007 have been incorporated into the digitized Official Zone Maps for Delaware County, Indiana which have been on display in the Delaware-Muncie Metropolitan Plan Commission, Room 206, Delaware County Building; and

WHEREAS, the Delaware-Muncie Metropolitan Plan Commission found the official digitized zone maps to be correct in reflecting the zone changes, adopted on the 7th day of February, 2008; and

WHEREAS, said Ordinance further states that the zone maps shall be submitted to the Delaware County Board of Commissioners for review and approval.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF  
DELAWARE COUNTY, INDIANA, AS FOLLOWS:

Section 1. That the 2006 and 2007 zone map changes shall become a part of the Official Zone Map and are hereby adopted and incorporated as the Official Zone Map for Delaware County, Indiana.

Section 2. That the digital version of the Delaware County Zone Map shall become the Official Delaware County Zone Map.

Section 2. That this resolution shall be in full force and effect from and after its passage by the Board of Commissioners of Delaware County, Indiana, this 17 day of MARCH, 2008.
