WHEREAS, due to the economic condition in Delaware County, the funding is not available to repay said temporary loan in its entirety



THEREFORE, BE IT RESOLVED by the County Council of Delaware County, State of Indiana, that:


- 1. That the balance of \$3,030,061.00 on the temporary loan from the Rainy Day Fund will not be repaid.


